

NOTICE TO BIDDERS:

Bidders must acknowledge receipt of this addendum prior to the hour and date set for the bid due date by one of the following methods:

- (a) By acknowledging receipt of this addendum on the proposal form submitted.
- (b) By email or fax which includes a reference to the project and addendum number.

The bid documents require acknowledgment individually of all addenda to the drawings and/or specifications. This is a mandatory requirement and any bid received without acknowledgment of receipt of addenda may be classified as not being a responsive bid. If, by virtue of this addendum it is desired to modify a bid already submitted, such modification may be made by email or fax provided such an email or fax makes reference to this addendum and is received prior to the opening hour and date specified above.

The Bid documents for the above project are amended as follows (All other terms and conditions remain unchanged):

CONTRACT PROVISIONS AND SPECIFICATIONS

- 1) **Instructions to Bidders Item #3 Minimum Qualifications**, Remove and replace item a),b) and last paragraph
 - a) Bidders must provide in writing that they have **three years** prior experience producing complex modules like/ or greater than as described in this ITB
 - b) Bidders must provide in writing that they have staff with **five years** of experience in fabricating complex modules like /or greater than as described in this ITB.

A Bidder's inability to provide the requested documentation related to proof of their ability to meet the minimum qualifications requirements at time of bid opening may result in their bid being declared non-responsive.

The Authority strongly desires that bidders submit all supporting information with their bid, so that a detailed analysis and determination can be made by the Contracting Officer that the bidder meets the minimum qualifications. However, provided a bidder meets the minimum qualifications for a definite, firm, unqualified, and unconditional determination, the Authority reserves the right to request additional information from the bidder, after the bids have been opened, to ensure that the bidder experience provided meets the intended ITB requirements.

DRAWING

- 1) **Sheet A1 Architectural General Notes #9**. Remove and replace,

"Finish Exterior walls and Skids (All exposed vertical exterior surfaces) with one coat of Aliphatic Urethane Enamel, Devoe Devthane 389 and/ or equal product, color white, to 3 Mills dry film. Bidder must provide product literature sheets of product if different then Aliphatic Urethane Enamel, Devoe Devthane 389."

QUESTIONS AND ANSWERS

1) **Question:** Can the bid opening be extended to December 21st.

Answer: Bids are due November 29, 2018 at 2:00 pm Alaska prevailing time.

2) **Question:** Is bid bonds and other security bonds required?

Answer: No, this is a commodity contract and is not required.

3) **Question:** Will AEA consider including structural fabrication and outfitting in the same solicitation.

Answer: No, See Addendum #1 item 5)

4) **Question:** Is applicable state and federal acquisition rules in the ITB.

Answer: See Addendum #1 item 2)
